For each activity that is proposed, at least 70% of the funds must benefit low- and moderate-income persons. Service Area #1 Grassy Lakes Potable Water Treatment Plant (WTP) – Air Compressor

03J – Water Tank/Well/Treatment Plant Improvements: The existing air compressor at the Grassy Lakes WTP is undersized and 50+ years old, which results in inefficient operation of the two (2) hydropneumatic tanks on site. The Town of Interlachen proposes to replace this existing air compressor, along with the associated piping, electrical, and controls. The new air compressor will allow for improved WTP operations and more consistent system pressures. The Grassy Lakes WTP is located behind the Interlachen Police Station at 101 N Manitoba Avenue in the Town of Interlachen.

Service Area #1 Tremont Potable Water Treatment Plant (WTP) – Pressure Valves

03J – Water Tank/Well/Treatment Plant Improvements: The Town of Interlachen proposes improvements at the Tremont WTP consisting of the installation of an altitude pressure valve on the Elevated Storage Tank, along with associated yard piping, electrical and controls upgrades, which will allow for the Tank to automatically close and prevent the tank from overflowing during system interconnect scenarios. Additionally, the improvements will also include the installation of approximately three (3) Pressure Reducing Valves (PRVs) at the Town's distribution system interconnecting locations to allow for more reliable system pressures and to assist in providing additional fire flow / pressure during fire flow events. The new valves will allow for improved WTP operations and more consistent system pressures. The Tremont WTP is located on Tremont Street between Manitoba Avenue and Francis Street in the Town of Interlachen.
